Submitted forms that are only partially completed or not accompanied by the supported documentation will not be processed. The submission on the mentioned documentation does not guarantee a media pass will be granted.

Supporting Document Requirements

- 1. A letter of accreditation from an editor of a recognised publication/agency or media organisation. This must be on official headed paper and signed by the accreditor.
- 2. Evidence of valid Public Liability Insurance cover at a minimum level of £5000,000.
- 3. Three examples of relevant, recently published work for which you have been clearly credited.
- 4. A signed copy of the Media Accreditation Indemnity and Acknowledgment form.

- 4. I will at all times observe and obey all instructions given to me by any official of the meeting or venue owner.
- 5. I confirm that I am over 18 years of age and am not suffering from any mental or physical disability that would impair my judgment or prevent me from acting in a safe manner or impair my mobility.
- 6. I will familiarise myself with the circuit, its layout and features before commencing my activities and will satisfy myself that the areas to which I wish access are available and suitable for my purpose.
